A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the end of the exchange period given that the transcript form and all relevant course work have been submitted by the student.

Termination of the agreement. The inter-institutional agreement may be amended by mutual agreement. The inter-institutional agreement may be terminated by either party. In the event of unilateral termination, a notice of at least one academic year should be given. In the event of such notice being given, all existing commitments to staff or students will be fulfilled. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

### **E VIG001: grading system**

The student workload consists of the time required to complete all planned learning activities (lectures, seminars, etc.) and private study (preparation for exams, writing of papers, reading, etc.): 1 ECTS credit= 25 hours.

Marks / Definition

Matrícula de honor (10) EXCELLENT - outstanding performance with only minor errors: just in very exceptional cases.

Sobresaliente (9.0\_9.9) VERY GOOD - above the average standard but with some errors.

Notable (7.0\_8.9) GOOD - generally sound work with a number of notable errors

Aprobado (5.0\_6.9) SATISFACTORY/SUFFICIENT - performance meets the minimum criteria. Average performance.

Suspenso (less than 5) FAILED
